Whereas, the above-captioned matter arises from a Complaint that was filed on July 27, 2017, by Debra Kwapniewski (Complainant), alleging that Ryan Curioni (Respondent), a member of the Lodi Board of Education (Board), violated the School Ethics Act (Act), N.J.S.A. 18A: 12-21 et seq.; and

Whereas, and more specifically, the Complaint alleges that Respondent violated N.J.S.A. 18A:12-24.1(a), N.J.S.A. 18A:12-24.1(c), N.J.S.A. 18A:12-24.1(d), N.J.S.A. 18A:12-24.1(e), N.J.S.A. 18A:12-24.1(g), N.J.S.A. 18A:12-24.1(i) of the Code of Ethics for School Board Members (Code); and

Whereas, at its meeting on November 28, 2017, the School Ethics Commission (Commission) voted to find the Complaint not frivolous and, pursuant to N.J.A.C. 6A:28-10.8(a), voted to transmit the above-captioned matter to the Office of Administrative Law (OAL) for a plenary hearing where Complainant would carry the burden to prove the allegations set forth in her Complaint; and

Whereas, the above-captioned matter was ultimately scheduled for a hearing on February 13, 2019, and on that date, Respondent failed to appear; and

Whereas, on June 27, 2019, the Honorable Elissa Mizzone Testa, ALJ (ALJ Testa), issued an Initial Decision detailing findings of fact, legal conclusions, and a recommended penalty; and

Whereas, at a special meeting on August 30, 2019, the Commission adopted a decision remanding the matter to the OAL so that (1) the specific facts in the record which support each violation can be more fully explained and (2) the issue of Respondent's entitlement to "free speech" protections can be more fully analyzed; and

Whereas, on October 24, 2019, ALJ Testa issued an Initial Decision (On Remand), and found that Complainant had proven by a preponderance of the competent and credible evidence that Respondent's actions, as pled in the Complaint, violated N.J.S.A. 18A:12-24.1(a), N.J.S.A. 18A:12-24.1(c), N.J.S.A. 18A:12-24.1(j); and N.J.S.A. 18A:12-24.1(j); and

Whereas, based on the findings of fact and legal conclusions in her Initial Decision, and because she found that Respondent should have "taken greater care" than to post inaccurate information and disparaging comments about Complainant on social media, ALJ Testa recommended a penalty of no less than six (6) months; and

Whereas, at its meeting on December 17, 2019, the Commission voted to adopt ALJ Testa's findings of fact; to adopt the legal conclusion that Respondent violated N.J.S.A. 18A:12-24.1(c), N.J.S.A. 18A:12-24.1(e), N.J.S.A. 18A:12-24.1(g), and N.J.S.A. 18A:12-24.1(i); to reject the legal conclusion that Respondent violated N.J.S.A. 18A:12-24.1(a) and N.J.S.A. 18A:12-24.1(d); and to modify the recommended penalty of suspension for "at least six (6) months" to suspension for six (6) months; and

Whereas, the Commission's decision was forwarded to the Commissioner of Education (Commissioner), pursuant to N.J.S.A. 18A:12-29, for his final determination on the recommended penalty; and

Whereas, Respondent filed Exceptions to the Commission's penalty, but did not appeal the underlying findings of violations or otherwise include any argument(s) specifically seeking a reduction or elimination of the penalty; and

Whereas, by decision dated January 23, 2020, the Commissioner concurred with the penalty recommended by the Commission, and agreed that "the severity, willfulness, and frequency of respondent's inappropriate conduct warrant[s] a suspension of six months"; and

Whereas, N.J.A.C. 6A:28-10.12(d) provides that for a penalty of censure, suspension or removal, a Resolution shall be adopted at the Commission's next meeting following the Commissioner's decision, and the Resolution shall be read at the Board's next public meeting following adoption by the Commission, and shall be posted in such places as the Board posts its public notices for no less than thirty (30) days; and

Now Therefore Be It Resolved, that the Commission adopts this Resolution stating that Respondent is hereby SUSPENDED as a school official for a PERIOD OF SIX (6) MONTHS as a penalty for having violated the Act as set forth herein; and

Be It Further Resolved, that the Board is ordered to read this Resolution at its next regularly scheduled public meeting, and to post it in such places as the Board posts its public notices for a period of no less than thirty (30) days; and

Be It Further Resolved, that the Board shall provide the Commission with the minutes, once adopted, from the meeting at which it reads the within Resolution.



MEMORANDUM OF UNDERSTANDING BETWEEN BERGEN COUNTY PROSECUTOR'S OFFICE (LEAD PROPOSER) AND LODI PUBLIC SCHOOLS

FORMALIZED ROLES, RESPONSIBILITIES, AND RESOURCE COMMITMENTS RELATED TO THE BERGEN COUNTY PROSECUTOR'S OFFICE PROPOSAL TO THE FY2019 USDOJ BJA STOP SCHOOL VIOLENCE GRANT PROGRAM

WHEREAS, the USDOJ BJA's STOP School Violence Grant Program FY 2019 Competitive Grant Solicitation is designed to improve school security by providing students and teachers with the tools they need to recognize, respond quickly to, and help prevent acts of violence; and

WHEREAS, the Bergen County Prosecutor's Office will partner with the Lodi Public Schools in order to make an application to the USDOJ BJA's STOP School Violence Grant Program FY 2019 Competitive Grant Solicitation to ensure that the improvements to be funded under this proposal are consistent with a comprehensive approach to preventing school violence and are individualized to the needs of each school at which those improvements are to be made; and

WHEREAS, it is the goal of all parties to this Memorandum of Understanding (MOU) to act in the best interest of the residents of Bergen County;

NOW THEREFORE BE IT RESOLVED, that the parties of this MOU confirm and endorse the aforesaid.

BE IT FURTHER RESOLVED, that the parties to this MOU confirm the following roles, responsibilities, and resource commitments per each entity:

Bergen County Prosecutor's Office

Role: The Bergen County Prosecutor's Office will act as the Lead Applicant of this proposal.

Responsibilities: (1) To serve as the sole entity under whose name the proposal will be submitted and the sole entity with whom the USDOJ BJA will execute a contract upon award; (2) To execute the complete effort specified in the grant proposal and contract; (3) To receive and disburse funding as approved by the USDOJ BJA; (4) To procure any outside services as described within the proposal to ensure professional quality, technical accuracy, and timely completion and submission of all deliverables; (5) To act as the sole entity responsible for reporting to USDOJ BJA with any and all documents, deliverables, and/or data requested.

The Bergen County Prosecutor's Office will partner with Care Plus NJ to complete the aforementioned school violence prevention activities.

Responsibilities: (1) To participate in the planning and coordination of training directed and organized by the Lead Applicant; (2) To act in a manner/provide sufficient information to ensure professional quality, technical accuracy, and timely completion and submission of all deliverables prepared/completed by the Lead Applicant; (3) To provide data and compliance documentation when requested from the Lead Applicant; (4) To leverage existing programs, resources, and internal expertise of the district/school so the Lead Applicant may best achieve the goals of the STOP School Violence Grant Program; and (5) To ensure long-term collaboration with all partners in order to work toward improving school security.

TERM OF MEMORANDUM OF UNDERSTANDING

This MOU is conditional upon successful award of a grant between the USDOJ BJA's STOP School Violence Grant Program FY 2019 Competitive Grant and the Bergen County Prosecutor's Office. If awarded, this MOU will have a term of 36 months from the date of a grant award (anticipated October 1, 2020). This MOU may be terminated earlier upon written notice from any and all parties to this MOU. Similarly, any and all parties to this MOU may include addendums to add additional partners as needed and appropriate.
